- Appellate decisions affecting process servers
 - Dynamex decision changing the independent contractor classification
 - Party may prevail on a motion to quash subpoena, even after the subpoena is withdrawn
 - No constitutional exceptions for a corporation to resist a subpoena on 5th Amendment Grounds
 - Conflicting statutory language for serving notice cannot be interpreted in a manner that creates and unreasonable and unintended result contrary to legislative intent
